When alterations are approved, an in-principle approval will be issued for six (6) months. If alterations are not finalised during that time, you will need to request an extension. Any extensions are in effect for a further six (6) months from the date of extension. If alterations are not completed within a 12-month period from the date of the initial approval, then the approval will lapse and you will need to apply again, with full paperwork and another payment. Please note that approval of alterations by the Tasmanian Pharmacy Authority does not automatically infer that section 90 pharmacy approval will be granted by the Australian Community Pharmacy Authority (ACPA).
